Use of Proxies for District-Level Delegate Elections

Per the approved ADP Delegate Selection Plan and DNC Rules, “An accredited participant in a caucus, convention or committee meeting, after having established credentials, may register a non-transferable proxy with (i.e., deliver a signed proxy to) another duly accredited participant at that meeting (except where an accredited alternate is present and eligible to serve as a replacement), provided that no individual may hold more than one (1) proxy at a time. (Rule 17 & Reg. 4.30)”

What this means:

- If you are a verified precinct committeeperson (PC) elected or appointed by March 1, 2024, you are eligible to vote in the caucuses being held April 20, 2024, to elect the allocated district-level delegates to the 2024 Democratic National Convention.
- You will vote only for those delegates running in your Congressional district caucus.
- Notification of the April 20 meeting will be sent electronically no later than March 18, 2024.
- If you are unable to attend the virtual election meeting in person, you may assign your proxy to another eligible PC to vote on your behalf.
 - “Assigning a proxy” means you are giving the person holding your proxy your vote in these elections.
 - “Eligible” means another PC from your congressional district who is not currently holding a proxy for anyone else.
 - Because the meetings are virtual, your proxy cannot be instructed (that is, you cannot tell the proxy holder who to vote for).
 - Once assigned, you are no longer eligible to vote in these elections.
- If you cannot attend the April 20 caucus and wish to assign your proxy to an eligible PC, you can download the form [here](#).
- Please verify with the individual that they are NOT currently holding another proxy.
- The form must be completed in its entirety and attested to by two (2) witnesses or a notary public.
- The forms are due to the ADP by 11:59 pm Wednesday, April 17.
 - They can be scanned and emailed to 2024delegate@azdem.org **OR**
 - They can be mailed to Arizona Democratic Party, PO Box 36123, Phoenix, AZ 85067 **NOTE: They must be received by April 17 or they cannot be accepted.**

Per the 2024 ADP Delegate Selection Plan, an accredited participant in a caucus, convention or committee meeting, after having established credentials, may register a non-transferable proxy with (i.e., deliver a signed proxy to) another duly accredited participant at that meeting, provided that **no individual may hold more than one (1) proxy at a time**. (DNC Rule 17 & Reg. 4.30)

- You may use an online Notary service. Witnesses may observe your signing of the document in person or via video and may provide their signatures electronically on your form.
 - It is your responsibility to contact and inform the person to whom you have assigned your proxy.
 - Submit your **proxy form directly to ADP**, not to the person to whom you've assigned your proxy.
